 - b. Discussion:
 - i. Internal Audit Report Re Distributed Servers The Deans Office was unaware of this audit, apparently COB Computing was contacted in advance of the audit, but their area was not surveyed. The audit, conducted by BKD identified a number of security and operational concerns. While there may be some merit to

- centralizing servers, Computer Services primary concerns include: physical security, up-to-date software/configurations, backups, and adequate power & environmental controls.
- ii. SEM Update A draft of the SEM goals is being presented to the BOG on Thursday. The goals were drafted by the SEM Committee and reviewed by Councils. Our Career Guide is going out to AR, IL, OK and KS. Collaborating with other colleges is a positive action for enrollment and retention, as well as gaining efficiencies. Example - The Economics Department has proposed select online ECO classes be offered to MBA students as electives. These online ECO classes could reduce demand for current MBA electives, which are often oversubscribed.

SOA Director – Our final (4th) candidate is currently on-campus. Plan is to make an offer next week.

MGT DH – Feedback from committee, DHs and Assoc. Deans is pending, goal is to extend an offer before break.

MGT Assistant Professor – Candidates have been interviewed, and an offer should be extended very soon.

BAC Academic Advisors – One new advisor will be starting this month, an offer should be going out soon for the second advisor. Interviews should start soon for a third new advisor to replace a recently vacated position.

MKT Assistant Professor (LSCM) – Interviews started today. The goal is to identify a finalist and extend an offer prior to the holidays.

ITC Instructor – To accommodate shifting demand among IT options, an instructor position is being repurposed to facilitate hiring someone with a cybersecurity background.
