If the I-9, W-4s, and direct deposit paperwork has been completed by the candidate, include these documents as well.

Exempt Employees

Exempt Staff, Administrators and 12 Month Faculty will utilize this system for Leave Reporting where they will record any leave taken during the reporting period. The Leave Reporting period for Exempt Employees is the 1st of the month through the last day of the month.

Nonexempt Employees

Nonexempt (overtime eligible) Employees will input hours worked into the Web Time Entry system. All hours entered must reflect the accurate hours and days the work is performed. The Pay Periods for Nonexempt Employees run from the 16th of the month to the 15th of the following month as outlined in the Payroll Calendar for Nonexempt Staff.

Part-Time and Student Employees

Part-Time and Student Employees will also report their hours using Web Time Entry. All hours entered must reflect the accurate hours and days the work is performed. The Pay Period for Part-Time and Student Employees will be semi-monthly; the 1st through the 15th of the month and the 16th of the month through the last day of the month.

Approver

An Approver is the individual who has the ability to update, change, return, or approve the Time Sheet and/or Leave Report submitted by their Employee. The Approver is responsible for ensuring that all of their Employees submit their time worked or leave taken for the Pay or Leave Period.

Proxy

Proxy is the individual designated by the Approver in the system to act on their behalf to update, change, return, or approve the Time Sheet and/or Leave Report submitted by their Employee.

Department Time Entry

Some departments will record time through another process called Department Time Entry. A designated person in the department collects the Time Sheet information for all of their Employees and enters it on the system for submission to Payroll for processing.

- 1. Retiring faculty members must meet the qualifications for Emeritus status as stated in the *Faculty Handbook 3.6.1*, http://www.missouristate.edu/provost/facultyhandbook/.
- 2. To be eligible for the title, the faculty member must also satisfy the following requirements: (a) completion of at least ten years of full-time academic service to Missouri State University (some exceptional senior faculty may be recognized with fewer than ten years of service), and (b) retirement status or disability status at Missouri State University. Emeritus status is awarded through affirmative vote of the full-time faculty in the department in which the candidate holds appointment and by favorable administrative action. Once someone has been approved, please complete the following.
 - Prepare the Personnel Action Form and submit it along with a copy of the retirement letter to the COB budget officer.
 - The effective date for Emeritus status cannot begin until the first day of retirement.

Exam Proctoring Policy - COB

- Administrative assistants are not to proctor exams.
- Graduate assistants may not proctor exams in classrooms unless instructor is present.
- One graduate assistant <u>may</u> proctor one or a small number of students taking makeup exams.
- If an emergency should arise, the department head and faculty member may arrange for two graduate assistants to proctor an exam in the classroom.

Faculty members are expected to be present in the examination room throughout all exams during their course. If an instructor will not be present during one of their exams then their department head should be notified. In consultation with the department head, the faculty member must arrange for another faculty member to proctor the examination in their absence. As a last resort, should another faculty member not be available, the department head and faculty member may arrange for two graduate assistants (minimum) per room to proctor an examination.

If a faculty member gives a make-up exam, then the make-up exam must be proctored as well. The faculty member must be present in the room with the student during the administration of the make-up exam, or may arrange for a graduate assistant to proctor the make-up exam. One graduate assistant is adequate to proctor one or a very small number of students taking make-up exams simultaneously, but two graduate student proctors would be required in the extremely rare

Per University policy, administrative assistants are not to proctor examinations. Per COB policy, only faculty members (or graduate students in rare instances as provided for above), are permitted to proctor examinations.

External Review Process Guidelines

Department Heads are responsible for managing the external review process. They work with the faculty applicant and Department Personnel Committee to ensure an appropriate pool of potential reviewers and selection of the final individuals from whom reviews will be solicited. Department Heads send out the faculty applicant's materials and ensure that reviews are returned on time. They place the reviews within the applicant's dossier so that they are available for all subsequent levels of evaluation.

Family Educational Rights & Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) afford students certain rights with respect to their education records. Please see the above link for more information.

What information should <u>never be released</u> to a third party without written consent from the student?

- Social security number: A student's social security number may not be used either alone or in combination with other data to identify a student when disclosing or confirming directory information, unless the student has provided written consent. Instead, other directory information should be used to identify students. When a person submits a student's social security number along with a request for directory information, the person should be informed that the University has not used the social security number to locate the student's records and that the University's response does not confirm the accuracy of the social security number supplied with the request for directory information.
- Citizenship
- Gender
- Ethnicity
- Religious preference
- Grades
- GPA
- Daily class schedule: This is very important. Local police authorities may be trying to find your student. Parents may be asking what classes the student is in today. You can't give that out. This even means to parents who are paying the bills. If it is a health or safety related emergency, contact the Registrar, Dean of Students, or General Counsel to determine if an exception for disclosure can be made.

Is it a FERPA violation if an instructor or department leaves graded papers/exams in a stack outside of an office for students to pick up?

• Yes, anytime non-directory information such as grades, student ID, GPA, etc. is easily accessible and/or viewable by someone other than the student himself or herself, it is a FERPA violation.

Final Examination Week

The final examination period is used either for (a) the administration of final examinations or (b) other appropriate course-terminating activities. If the activity is something other than a final examination, a report must be filed with the department head indicating the nature of the activity and when it will take place. Faculty members are to be present for the final examination period. Exceptions require dean's permission and department heads permission at least one week in advance, except in the case of illness or emergency. Policy based on Senate Resolution 12-87/88 and Senate Action 8-80/81.

Financial Procedures and Internal Controls (COB)

The Dean must sign all PAFs in the College. The Department is responsible for initiating all PAFs except for specialty PAFs such as professorships, chairs, Department Heads or Directors, etc. The Dean's Executive Assistant prepares these types of specialty PAFs. A clarifying note regarding workflow of PAF's – after the Department Head, Director or Associate Dean signs a personnel action form (PAF) it is routed to Kate Mendenhall. Once the PAF is reviewed by Kate, it is sent to Laurie where it is logged; then Laurie gives it to Sherri to pass on to the Dean for the Dean's signature. After the Dean signs the PAF, she gives the document back to Sherri who gives it back to Laurie. Laurie then sends the PAF to the Provost's Office. To determine whether a PAF has been sent to the Provost's office, call Laurie.

Purchase Requisitions and Payment Requests

The person preparing the purchase requisition or payment request should indicate in the notes who the originator of the request is.

Purchase requisitions and payment requests for COB special events are handled by the Budget Officer, primarily because they involve contracts. Any COB event for which a contract must be signed must go through the Dean's office for signature of the contract. Only the Dean has signatory authority for contracts up to \$25,000. Contracts over \$25,000 must be approved by the Board of Governors. See guidance that follows for these events.

P-Cards

Use payment requests wherever possible. For regular relationships, we should be able to be invoiced.

P-cards should remain in the custody of the cardholder at all times. It is not to be loaned out for any length of time.

The custodian also keeps a log of all monthly transactions. In the departments, the custodian is also the coordinator, who is responsible for allocating p-card charges to the proper account codes. In the Dean's office, Laurie Bryson is the coordinator. All Dean's office personnel turn in their monthly p-card logs to Laurie for allocation to accounts.

Starting with the February 2016 transactions, upload and attach **ALL** P-Card receipts and logs into the bank's system. That way the back-up documentation can be viewed by your approver and also by the Budget Officer for COB. That being said, it is actually easier for you as a coordinator to attach all of the receipts in to the system as compared to attaching only a select few. You will need to scan all of the receipts per cardholder per month in to a single file and by using the 'Manage Receipt Images' link on your allocation page you will be able to link all of the transactions to that one file that has all of the documentation.

Travel

For travel, use our corporate account at Adelman Travel where possible. Enterprise reservations can be booked directly by the traveler through our corporate account. When hotel reservations are booked using a p-card, there is a form that can be filed with the hotel so the traveler does not need to produce the p-card when checking in. The person making the reservation can request the form from the hotel. This will have to be done for each hotel stay.

All travel should be pre-approved by the appropriate supervisor. Any travel not pre-approved is subject to be disallowed for reimbursement.

Travel expense reports are still completed by the traveler and approved by the supervisor.

Fire Protection Plan and Evacuation Routes

Fire Protection

This page describes what to do in the event of a fire, with the three most salient points related to evacuations being noted below.

- When the building evacuation alarm is sounded, an emergency exists:
 walk quickly to the nearest marked exit and ask others to do the same. Do
 NOT use the elevators!
- Once outside, move to a clear area which is at least 500 feet away from the affected building(s). Keep streets, fire lanes, hydrants, and walkways, clear for emergency vehicles and crews. Know your area assembly points.
- **Do not return to an evacuated building** unless permitted to do so by a University official.

Evacuation Routes

This page describes the evacuation routes for all MSU buildings. Below are the Facility Exit Route/Destinations for buildings most commonly used by COB.

- Glass Hall southwest to Strong Hall (900 S. Holland)
- Kemper Hall north to Glass Hall (851 John Q. Hammons Parkway)
- Park Central Office Building north to Levy-Wolf Building (110-111 Park Central)

- Food and/or non-alcoholic beverages may be purchased for a reception to honor a retiring employee, the departure of the President or Provost of the University, and to honor employee service.
- Food and/or non-alcoholic beverages may be purchased for University training only if the training is scheduled to last more than two hours.
- Food and/or non-alcoholic beverages may be purchased for University meetings not attended by
 guests of the University only if they occur during times outside the normal business hours of the
 University and when such meetings span the normal meal hour unless approved in advance by
 the President or Provost.
- Food and/or non-alcoholic beverages may be purchased for meetings of the Board of Governors, Presidential functions, and up to two retreats held annually by Administrative Council and University departments.
- Bottled water for water coolers for general departmental usage may be purchased with University funds as available resources allow.
- This policy does not limit the ability of the University to purchase food and non-alcoholic beverages for student events including student recruitment.
- When procuring food and refreshments, the user should comply with the applicable terms and conditions of the University's contracts for food services and concessions.

Gift Policy

The University has implemented a gift policy as well as accounting procedures for any items that are given as gifts during each fiscal year. They are as follows:

- It is the responsibility of each University department head, both academic and non-academic, to approve the appropriateness of using either University or Foundation monies to purchase a gift to express the University's appreciation.
- If a department head approves such a gift, be it from a recommendation of a faculty or staff member or another individual, the department head must complete a <u>Gift Reporting Form</u> at the time of the transaction and forward it immediately for appropriate signatures until it reaches the appropriate Vice President's office.
- Every fiscal year, each vice President is required to provide the President of the University with a composite list of all gifts given from departments in the vice President's unit.

Missouri State University officials understand that in certain instances it is acceptable to recognize a person by giving a gift which is intended to show the University's appreciation for the individual. It is incumbent on the University's officials to use good judgment in making such gifts, both in number and cost. In addition, it is imperative that good record-keeping procedures are in place and that the approval process is followed regarding any expenditures surrounding such gifts.

Grades – How to Enter

The GA will receive a letter of offer from the Graduate College which will confirm the GA position offer. The Employment Appointment Form will include the time frame of their appointment. They must review the details of their appointment, sign and return it to the Graduate College to officially accept their appointment.

PLEASE NOTE: Failure to return the signed employment agreement form to the Graduate College and complete the I-9, W-4, and Direct Deposit forms within a timely fashion may lead to cancellation of the offer and/or delay of their first paycheck.

If the person is a Foreign National Employee:

Foreign nationals cannot legally begin working until they have been cleared by International Payroll. If the graduate student is new (first-time) and has not previously been a student employee on campus, they are required to e-mail the <u>International Payroll Office</u> for a password to access the new on-line *Foreign National Information* form. Once they have completed the form, an appointment will be scheduled to finish the completion of the W-4, I-9, direct deposit form and any other appropriate tax forms.

If the G.A. is new and has previously been employed on campus as a student employee, they should send an e-mail to InternationalPayroll@missouristate.edu informing them that s/he will now be a graduate assistant and ask if s/he needs to go by to update any of their paperwork.

The Graduate College hosts two types of orientation sessions during the year. These sessions introduce graduate students and teaching assistants to the University resources and services available to them. For more information and orientation dates for upcoming semesters, please go to <u>Graduate Student Orientations</u>.

Teaching Assistant Orientation

The Graduate College provides an orientation prior to the fall semester for all new and returning graduate teaching assistants. The orientation sessions are designed to provide students with information relevant to their academic role as well as graduate assistantship responsibilities. As part of this orientation, there will be workshops on legal issues related to teaching and a variety of sessions focusing on effective teaching strategies. Students having assistantship responsibilities that include direct or indirect teaching must participate in this part of the pre-semester orientation. In most cases where Graduate Assistants have instructional responsibilities, the academic department also provides formal orientation and training sessions for the specific teaching assignments.

Departmental GA Meeting (Optional - Usually held the week before classes begin)

Department Administrative Assistants and/or Department Heads typically meet with all the graduate assistants to review expectations and the policies and procedures of the department. Here are a few topics to discuss with new graduate assistants.

- Quality of Work accuracy, thoroughness and neatness
- Quantity Good utilization of overall work time
- Dependability Extent to which he/she can be relied upon to follow instructions and carry out job assignments.
- Attitude Willingness to cooperate, be supportive and courteous.
- Attendance Prompt for appointments and willingness to notify department staff and faculty when he/she will be absent.
- Integrity Demonstrate ethical behavior and strict maintenance of confidentiality of information. (Grades, tests, faculty evaluations, etc.)
- Personal Effectiveness Show desire to improve, take initiative in responsibilities, and manage time and priorities.
- Office hours and schedule
- Test Proctoring
- Dress code wear shirts provided by COB Dean's Office; no shorts, no flip flops, no gym clothes. Jeans are allowed.
- Office Hours and Time Sheets
- Grading accuracy and confidentiality
- Faculty Evaluations confidentiality
- Teamwork and time management let's all work together
- Appropriate assignments

Hours and Timesheets

- Work 20 hours per week on average.
- Begin work the week prior to the start of classes and continue through graduation.
- They are not required to work University holidays and student-only holidays.

The following list includes traditional workdays that graduate assistants **are not typically required to work**.

Fall semester: Labor Day; Fall Break; Thanksgiving Break; Study Day (or if the student works on Study Day, then the day of fall commencement)

Spring semester: Martin Luther King; Jr. Day, Presidents' Day; Spring Break; Spring Holiday; Study Day (or if the student works on Study Day, then the day of spring commencement)

Summer semester: Independence Day

GA Timesheets

Access the graduate assistantship <u>timesheet</u>.

The GA Timesheet form should be used by all Graduate Assistants (Gas) who are not Teaching Assistants or Graduate Research Assistants.

- At the end of the month, they should sign and date the time record and submit it to their supervisor for verification and signature.
- Monthly timesheets should then be submitted to the Department Head for review, signature and retention. For any weeks of over 31 hours worked, a copy of the timesheet should be sent to Payroll on the first working day of the following month. If the week spans two months, copies of both months should be sent to Payroll as soon as possible.
- Departments should retain time records for a minimum of three (3) years.
- Completed forms are subject to random auditing. Departments that are out of compliance with these retention guidelines are subject to corrective actions that may include losing their right to hire graduate assistants.

Termination/Resignation

Contact the Graduate College as soon as a termination or resignation is known.

Resignation/Termination of an assistantship by a student or by a department/unit must be made in writing. As soon as a graduate assistant has been terminated or has resigned, a copy of the letter of termination/resignation and a corresponding Personnel Action Form (with the termination action checked) should be sent to the Graduate College. Failure to complete a Personnel Action Form in a timely manner for a student who has been terminated or has resigned, may delay appointment of a replacement assistant.

Graduate Assistantships – Student Application Process

Application Process (to be completed by the graduate student)

The student obtains a Graduate Assistantship Application from the Graduate College Office (Carrington Hall 306) or from the <u>Graduate Assistantships</u> web page. Completed applications and resumes (if required) should be submitted to the department in which the assistantship is sought. The Graduate College is not involved in the initial hiring process of the individual departments/offices.

NOTE: G.A. Application Forms should be retained by the department – not forwarded to the Graduate College.

Once the student has been offered a graduate assistantship position by a Missouri State department or office, they must complete the following steps to finalize their position.

- 1. **Review the letter of offer from the Graduate College.** This letter confirms the graduate assistant position offer and includes the time frame of their appointment and other pertinent information. If they decide not to accept the position, they should notify the Graduate College.
- 2. **Sign and return the Employment Appointment Form.** Review their address information, the appointment and stipend details, and then sign and return to the Graduate College to officially accept their appointment. They will receive a copy for their records in the mail once it has been processed.

All research and professional faculty recommendations must gain the majority vote of approval by the Graduate Council Membership Committee and be accepted by the Graduate Council.

Hiring Forms for All New Employees

(Includes Full-Time Faculty, Instructors, Per Course, Full and Part-Time Staff, Grad Assistants and Student Workers)

If an employee is new or has not worked on campus in the last year, they are required to complete the following forms. The hiring department is responsible to see that all paperwork for the new employee has been completed.

I-9 (E-Verify)

I-9 Employment Eligibility Verification

• I-9, Employment Eligibility Verification (include copies of supporting documents used)

Completion of the I-9 Form requires them to present documentation to **the hiring department** that establishes both identity and employment eligibility. Section 1 of the I-9 **must be completed during the period between the day the offer of employment is made and the end of the first day of employment.** Send form and copy of documentation to the COB budget officer. Please write "faculty, per course, graduate assistant, etc." in the upper right of the first page.

After the employee has completed Section 1 of the I-9, the department personnel will need to make photocopies of the I.D.s/documentation presented to attach to the form, complete Section 2 of the form, and forward the I-9 (with the copies of the I.D.s attached) to the appropriate person in the college or cost center for the E-Verify to be completed. Federal law requires the E-Verify be completed by *no later* than the end of the third day of the appointment period and that the first day of the appointment period is always 1 week prior to the start of classes.

Note: Please review Section 1 to verify that

- Each box in Section 1 has been filled in even if (N/A Not applicable).
- The dates in this section and the signature line are written as (mm/dd/yyyy)
- Must be completed in ink.

- At the very top right-hand corner, please write Graduate Assistant, Per Course, Full-Time Faculty, etc.
- Submit completed I-9 to COB Budget Office (cost center).

Completion of the W-4s and Authorization Form for Direct Deposit of Payroll is to be done in the hiring department/office.

Be sure they sign and date the forms. Do not fill out in pencil.

Each payday, employees' net pay will be deposited directly into their bank account by providing an authorization for Direct Deposit. Authorization may also be accomplished by completing an <u>Authorization for Direct Deposit of Payroll</u> form. The form may be filled out online or printed for completion.

Hiring Department Files for Faculty

The hiring department is responsible for completion and retention of the hiring file. The hiring unit's file for a faculty position should contain the following:

Candidate Folder Checklist

- Careful completion and retention of these files by the hiring department provides protection in two ways. The files provide documentation of "good faith" recruiting procedures. Should it be necessary, they also provide an official record for use in investigating complaints of discrimination in the selection process.
- The completed hiring file, **including the application materials of all applicants for a position**, **must be retained by the department for a minimum of two years** from the date of the personnel action as required by federal regulations. At the end of two years, the records regarding unsuccessful applicants should be destroyed.

Hotel Reservations – see University Plaza Hotel

While making the hotel reservation, most hotels require upfront payment, which will then be reimbursed using a Travel Expense Report. If that is not possible, the department will use their procurement card to get a confirmation number and also get a CREDIT CARD AUTHORIZATION FORM from the Hotel and attach it to supporting documentation that is sent to Procurement Services.

The University Plaza will also direct bill the departments when faculty candidates visit campus. Be sure to contact the hotel and complete the Direct Bill Authorization Form prior to making reservations.

Key Request Authorized Signature Policy

Only College Deans, Department Heads, Directors or Vice Presidents are approving authorities for key issuance and will determine those individuals whose duties and responsibilities require possession of keys.

- Any key issued to faculty, staff, or students must be signed for in the Key Control Office, located at 945 E Grand/108 Central Stores and Maintenance, Monday Friday between 10:00 a.m. 3:00 p.m.
- Administrative Assistants and graduate assistants are *not* allowed to pick up keys for other employees.
- All employees must show proof of identification and sign for their keys in the presence of the Key Control person.
- When a person leaves Missouri State University, keys must be turned in to the Key Control Office before clearance forms will be signed.
- No students or graduate assistants will be issued <u>master keys</u> of any type.
- Each year, during the month of January, an audit will be conducted by all approving authorities for all keys issued under their approval. This will help to ensure proper control and accountability of all university keys.

NOTE: New faculty usually receive an office key, Glass Hall SW entrance key, and a computer cart key CH 751. Their office key will also unlock the door to the mailroom.

Administrative Assistants II are issued a floor master key to the respective floor where their department office is located.

Graduate Assistants are issued a key to their office.

Late Time Entry

Late Time Entry: If you have an employee who failed to turn in a time sheet or hours from a <u>previous pay period</u>, the hours must be reported under "Late Time Entry" on the this time sheet. Enter the total number of missed hours on the first day of the pay period using the "Late Time" earn code and provide the details of each date and the number of hours on each date in the "Add Comments" box. - Do not use building and room number because campus mail is sorted by department. Please forward misdirected mail to the correct department or return to Postal Services.
- Items submitted without campus mail envelopes should contain the words "Campus Mail" in the upper, right corner. Campus mail envelopes may be purchased from Central Stores or ordered from Office Depot.

Outgoing mail:

Any official University mail expected to have U.S. postage computed and affixed by Postal Services should have the bar-coded FOPAL (budget number) in the lower left hand corner of the envelope. If the envelope does not contain the barcode, then it must have the FOPOAL (budget number) to be charged placed in the upper right hand corner of the envelope. Mark only the top envelope for multiple pieces to be charged to the same FOPOAL (budget number) and bundle these pieces with rubber bands in order to keep them together. Please avoid using post-it notes or scrap paper; write directly on the mail piece.

- **Do not apply stamps to university mail.** Postal Services will utilize the centralized metering service to affix the correct postage amount on all official University Mail based on the appropriate mail classification. Exceptions need to be cleared through Postal Services.
- Departments may purchase stamps at the PSU Postal Station for emergency mailings which occur after 4:00 p.m. and weekends.
- All mail must have a return address or it will be returned to the department.

Organizational Dues and Memberships

- University funds may be used to pay for institutional memberships in professional societies or associations.
- University funds may be used to pay for individual memberships in, and continuing education sponsored by, professional societies or associations as approved by the President, Vice Presidentlevel employees, or Deans, as available resources allow.
- Individual memberships are limited to no more than two per employee and up to two additional individual memberships if approved by the Dean. Any additional individual memberships must be approved in advance by the President, Provost, or Vice President-level administrator.
- University funds may be used to pay for individual civic club memberships only for the President, Provost, Vice President-level employees, or Deans as available resources allow.
- Each cost center administrator must report all individual memberships purchased to the President annually. See instructions.

- Missouri State University Outlets are the only recruitment resources used for Per Course postings with the Missouri State University website applicant portal as the recruitment outlet.

Creating New Per Course Faculty Postings

You will be able to create your new posting from your previous posting.

- 1. Make sure you are in the role of Department User or Department Approver. Under Shortcuts select Create New per Course Faculty Posting
- 2. Select **Create from Posting** if you are the one who created the last per course posting. If you are not the person who created the last posting you will use **Create from Position Type** (your posting will truly be new and have to fill in all the information).
- 3. Select the Posting you wish to create from. It will open to show you the content of the posting. You then select the **Green Circle with the Plus Sign in it that says Create Posting from this Posting**. Double check your title. It should be **Per Course Faculty (Summer/Fall 2016 Semester). You will edit the title and then select the Orange**

button labeled Create New Posting. Remember to not put your Department in the Position Title. It will be listed on the Posting in a different column.

- 4. The posting will come up on edit mode. Quickly review the posting and make minor edits as needed. Some of the items you will probably want to update are:
 - a. Begin Date of Appointment. Should be (first day of classes for summer) and (first day of classes for fall)
 - b. Review Description of Primary Duties to make sure nothing has changed
 - c. Make sure your Applicant Reviewers are correct. Remember these are the people who can move the Applicants to Hired or Not Hired
 - d. Update Open and Closed Dates. Do not use the Open until Filled check box
 - e. Update or leave the same the supplemental questions
 - f. Review Applicant Documents. Remember Cover Letter and CV are required.
 - g. If you need other faculty to review the applicants you would need to update the Search Committee Members
- 5. Once you are back to the Summary screen you will select the Orange Action button and send the Posting on to the Department Approver for Approval
- 6. When your Posting hits the Open Date it will be available to applicants to apply. We suggest sending an email to your repeat Per Course Faculty members with a link to your posting. The **Quicklink for Posting** on the Posting form will link them directly to your Posting. Since these Per Course Faculty applied last semester they will follow the link to your posting. Login with the account they created and apply to the posting. Their information will copy over. They will have to attach their CV and Cover letter, but this time they can use the function Use Previously Uploaded Document. This allows them to use the document they used last time. They will answer the supplemental questions and then Certify and

Instructions for Completing Personnel Action Form:

The Personnel Action Form (PD-003) is used to report appointments, terminations, a change in status, or compensation of an individual employee. The Personnel Action Form should be used each time there is an action that should be recorded in the individual's personnel file or that requires payroll action. Use it as a transmittal form for approval of the personnel action. Attach to the form all available supportive materials such as:

- Appointments official transcripts, W-4, I-9, direct deposit, etc.
- Resignations/Retirements letter from employee or standard resignation form.

Don't forget to include:

- Home department name
- Effective dates

Full-time 9-month Faculty

Fall & Spring—The Monday prior to the start of classes. The Appointment ends on commencement at the end of the academic year.

Per Course Faculty

Fall, spring & summer – Each appointment begins the first day of the official start of the semester & ends on commencement. Person must be appointed each semester.

• The first payment for fall is at the end of September.

- The first payment for spring is at the end of February.
- First payment for summer will take place in June with payment split over 2 months.

Record Retention of Faculty Personnel Items

In accord with policy guidelines set forth in the revised Faculty Handbook, the following documents shall be maintained in the personnel files housed in the Dean's office and academic departments of each college.

- Copy of the initial hiring letter
- Copies of all official transcripts, including written official verifications of the terminal degree
- Copies of all position authorizations and personnel action forms reflecting Provost level approval
- Copies of all reappointment communications. Tenure and/or Promotion Review forms, and yearly performance reviews from the Dean, Department Head, and RPT committee
- Copies of all communications to faculty from the Provost Office related to tenure and promotion
- Copies of any memorandum to faculty or staff originating from the Provost, Dean, or Department Head pertaining to a reprimand or other personnel action where placement in the personnel file is specified in the document.
- Responses from the Provost Office, Deans, or Department Heads to written appeals related to personnel matters and the pay for performance system
- Copies of all prescribed communications set forth by the approved university policy and procedures to faculty from the Dean, Department Head, and departmental personnel committee pertaining to the merit evaluations.
- Copy of the form documenting receipt of criteria for Promotion/Tenure in effect at time of faculty hire
- Copies of written communications of decisions made related to sabbaticals and other available leave options from the Provost Office, Dean, or Department Head
- Copies of any official document related to matters of immigration or visa status of faculty and staff who are foreign nationals. This includes notification of faculty and staff on university sponsorship of permanent residence
- Copies of official complaints under review by the Office of Equity and Diversity and the resolution of stated complaints
- Salary notifications
- Annual Leave Statements (12-month faculty only)

Note: Personnel files must be kept for the duration of employment. Files for former faculty should be kept for five years unless a person may return to the University or if there were personnel issues. The Office of Human Resources will continue to maintain personnel files which contain a set of all official documents.

The Office of the Provost will keep copies of the following items:

- Any correspondence that originates from this office (i.e., Promotion/Tenure Notifications, non-reappointment memos, grievances, etc.)
- Position Authorization forms, EOR and copy of appointment letter for all faculty hires
- Memos from deans re: annual reappointment
- Memos from deans re: outcome of pre-tenure reviews of faculty
- Requests for tenure clock stops or special leaves (including with and without pay)

Recruitment Reimbursement Guidelines

The College of Business will pay \$6,000 per line for candidate visits. Arrangements for transportation, lodging and meals are to be made by the hiring department.

It is recommended that the administrative assistant prepare a Missouri State University Travel Expense Report for the candidate to sign while they are still on campus. Obtain all itemized receipts from the candidate. Travel expense reports, initialed or signed by the candidate or faculty member, as well as department head, with **original receipts** (ITEMIZED and SPECIFIC) should be submitted to Financial Services. Payment Requests should be submitted to the COB Budget Officer.

Transportation: Travel should be arranged via the most reasonable and economical method available. Unless the ticket is purchased directly from a travel agent, departments must submit candidate's flight coupon or computerized receipt for verification of payment with travel expense form, signed by the candidate and department head, and then forwarded to Financial Services.

Mileage Reimbursement Rates for Personal Use of Vehicle: FY 16-17 is 0.37 per mile. Please include a MapQuest or Google Maps printout of actual mileage.

Lodging: Please refer to the University Plaza Hotel section in this manual. When making reservations, the MSU or corporate rate should always be requested. Interview stays are limited to two nights. If staying an additional day will substantially reduce the airfare, the cost savings is encouraged. Departments should instruct hotels to bill MSU for room charges only—no personal phone calls, movies, laundry services, etc. The bill should be mailed directly to the hiring department, which will complete a payment request for approval by the department head. Submit the completed form to the COB Budget Officer.

Meals: Please keep the number of people attending meals to a reasonable number. Generally no more than two faculty members are necessary for each meal. While the candidate's meals are fully reimbursable above the university's stated maximums, we are held to the maximums for faculty attending a meal (\$12/\$15/\$30) unless there are extenuating circumstances. Be careful about ordering the house specials at nice restaurants as these are often very expensive. Reimbursement guidelines for breakfast, lunch and dinner are shown in the chart below.

Meal	Maximum Number People	Reimbursable Amount	Maximum/Day
Breakfast	Candidate + 2	\$ 12.00	\$ 40.00
Lunch	Candidate + 2	15.00	60.00
Dinner	Candidate + 2	30.00	100.00

• Excluded in the reimbursement are meals for spouses of MSU employees and for all alcoholic spirits.

- Travel expenses for a candidate's partner can be reimbursed using Foundation funds at the discretion of the department seeking to hire a candidate. In the event that the candidate is hired, the amount reimbursed for the partner's travel is reported on the employee's W-2 form.
- Reimbursements for meals for a greater number of employees will be allowed if the total amount to be reimbursed does not exceed the maximum of \$40 for breakfast, \$60 for lunch and \$100 for dinner. These amounts include tips and taxes.
- Tips should be reasonable, approximately 20 percent.
- Whenever possible a tax exempt form should be used at the restaurant to save on sales tax. Tax exempt forms are available in the Dean's office.
- Meal requests or any expenditure of \$10 and over must have an original itemized receipt and the names of persons attending written on it and on the travel expense form.

Moving Allowance and Summer Appointments: (allowances are subject to change)

- a. Departments may pay for a house hunting trip out of foundation funds. This is optional and at the discretion of the department head as to whether this is provided and how much. If you wish to offer this to a candidate, the Dean's assistant will include that in a side letter and indicate that the department will be responsible for that cost on a candidate reimbursement basis.
- b. Tenure earning candidates are offered two options for summer 2016: 1) Two summer research appointments at \$10,000 each and no moving allowance; or 2) Two summer appointments at \$7,500 each and a \$5,000 moving allowance. When making an offer to a tenure earning candidate you should ask them which they prefer and then relate that to the Dean's assistant for inclusion in the side letter. These funds are paid by the College.
- c. The side letters should clearly state what the department is paying for and what the College is paying for.
- d. Fully executed copies of the appointment letter (prepared by the Provost Office) and the side letter should be retained in the Dean's Office in the individual's personnel file.

Employee Expenses Submitted for Reimbursement: (If faculty pick up the meal tab)

These are submitted on a Travel Expense Form

Fill out the top with employee's name, M-number, department, and office number.

If paying for meals, please include the candidate's name, faculty position, and the names of all faculty attending. Original receipts must itemize the food that was ordered by each guest—do not just submit the credit card receipt.

Travel Expense Reports for employee expenses incurred for searches must be signed by both the faculty member and the department head and then forwarded to Financial Services.

Recycling Procedures

Severe Weather

Senior administrators (i.e. deans, directors, and department heads) will ensure that all employees within their areas of responsibility read and receive direction to comply with this plan.

NOTE: Particular attention must be given to both new and temporary employees (e.g. seasonal workers, per course instructors, etc.) to insure that they are instructed by the responsible department. At the time of employment, each temporary employee will be instructed to contact the Building Coordinator in each building where they may be located, and obtain the locations of the designated shelter areas.

Overall rules that apply to all buildings include:

- Stay away from exterior windows and walls.
- Move to the core of the building.

Student Employment Services

A student employee is a part-time hourly employee who is concurrently enrolled at Missouri State University with the primary goal of achieving a degree and therefore, **must be degree seeking**. Thus, the employment is interim or temporary in nature and is incidental to the pursuit of an academic program. Students may not perform any work or subsequently be paid for work performed before all steps in the hiring process have been completed. The University may not employ students to work 1,000 hours or more during a rolling 12 month period.

Student Employment Clearance

Departments are responsible for **submitting a Student Clearance Form** to Student Employment Services to hire a student. This form allows student employees to be placed on the payroll system.

New student employees are required to complete the W-4, I-9, and Direct Deposit forms. These forms are available in the hiring department and must be completed before working. Students should be prepared to complete the I-9 form by bringing their proper identification and proof of eligibility to work. No faxes or copies of these documents will be accepted. A current voided blank check must accompany the Direct Deposit Form.

Student Organization Funding

Each COB student organization may receive up to \$2,700 per academic year. The number of events COB funds for a student organization is irrelevant. Of the allocation, \$2,500.00 is allocated for travel and other pre-approved expenditures. The remaining \$200.00 is allocated for printing services that can be obtained in the second-floor Glass Hall Computer Lab.

In most COB departments, funding will be provided on a reimbursement basis. Some departments may be willing to advance funds by making a purchase using an MSU procurement card. Talk with your department's administrative assistant for clarification on this.

Syllabi Policy Statements

Note: Course policy statements (print or electronic) <u>must be retained on file indefinitely</u> in the appropriate departmental/school office.

Within the first week of classes faculty members should issue a written policy statement, in print or in electronic form to each student summarizing the purpose, course objectives, attendance policy, textbooks grading scale, etc. Please check the <u>Provost website</u> for reference.

The <u>suggested wording for these statements</u>, as well as several other recommended policy statements can be found on the Provost website. Faculty who wish to compose their own wording or to expand on these statements must comply with the Faculty Handbook,

Each departmental office in the COB is responsible for collecting all course syllabi for each semester and maintaining a permanent file for future reference. Course policy statement guidelines can be found on page 38 of the Faculty Handbook or the Provost website.

Former students typically will ask for syllabi by course number; seldom do they remember the professor's name. Numerical order seems to be most efficient.

Tax Exempt Letter

Purchases and hotel charges by Missouri State are not subject to Missouri sales or use tax if such purchases are within the conduct of the University's exempt functions and activities. Purchases must be paid for from Missouri State funds and all sellers or vendors must be furnished a copy of an exemption letter. The exemption cannot be used on purchases by individuals or agents for their use.

Use tax exempt letter when making hotel reservations in Missouri. Remind faculty to take or fax a copy of letter to hotels located in Missouri.

TRAINING: Upon receipt of this form, the Payroll Office will automatically enroll the new Approver/Originator employee in the upcoming Banner Time Approver training class. The employee will receive an email indicating the training date, time and location.

In Section III enter the effective date that the Approver or Originator will begin their role. This date needs to be at the start of a pay period, i.e. the 16th of the month for a monthly-paid employees, or the 1st or 16th of the month for a semi-monthly-paid employees. Ensure that the effective date allows at least two weeks for processing once the Authorization Form is received in the Payroll Office.

Travel Advance/Authorization Form

The Travel Advance/Authorization Form should be completed and submitted for approval well in advance of the trip and before any travel arrangements are made. Faculty seeking reimbursement for some or all of the travel expenses from the university, must complete the Travel Authorization Form and submit it to the department head for approval.

- The business **purpose** and **dates** for travel should be explained and noted in the appropriate space on the Travel Advance and/or Foreign Travel Authorization Form.
- Travel requests must be **approved** by the department head or cost center administrator.
- Travel Authorization Forms that have been approved are **retained** within the department.
- Notify employee that their travel request has been approved so that they can make travel arrangements.

P-Cards may now be used to prepay the following expenses with an appropriate business purpose:

- airfare
- lodging (if hotel reservations are in Missouri, please use tax exempt letter)
- group travel
- tickets to events

Foreign Travel:

If the request is for **foreign travel**, please follow procedures in the **Foreign Travel** section.

- All foreign travel must be approved by the department head, Dean and the Provost
 <u>PRIOR</u> to traveling.
- The <u>Foreign Travel Authorization</u> form must be completed and approved before travel arrangements are made.
- Reimbursement requested <u>after</u> the trip and <u>without prior authorization</u> through the Provost level is subject to be denied in whole.

When employees travel outside of the United States for University-related business, expenses are reimbursable in accordance with procedures outlined in the travel policy. Particular care should be taken to obtain receipts for the Travel Expense Report.

- All receipts are to be converted into US dollars.
- For documentation, please print and submit the currency conversion rate (use Oanda) for the date the expense was incurred).
- All foreign travel should be primarily for business. If less than 25% of the time on the trip is spent on personal activities, the trip is considered entirely for business.

Travel Regulations and Expense Forms

It is the policy of the University to permit the employee, with the approval of the administrative supervisor, to select the method of transportation that best meets the needs of the University and the employee.

- University-owned vehicles
- Commercial transportation
- Personal car

University employees traveling long distances by motor vehicle are obligated to provide written verification of equivalent airfare. The airfare quote should be obtained from a travel agency or website and must represent the cost of a non-refundable ticket at the time of travel.

Expense Allowance for Food

Faculty can be reimbursed up to a maximum of \$57 per day. Original itemized receipts are required for anything over \$10.00.

Breakfast	\$12.00
Lunch	\$15.00
Dinner	\$30.00

Note:

- If the traveler is eligible for two meals for the day, the limit for the two meals combined is the total of the applicable meal limits listed above.
- If the traveler is eligible for three meals for the day, the meal limit is \$57/day. This amount can be allocated among the three meals without regard to the individual meal limits as long as the total does not exceed \$57.

Mileage Reimbursement Rates: FA 2016

Effective July 1, 2016 through June 30, 2017, the University's mileage reimbursement rates are as follows:

- Personal Use of Vehicle Within or Outside the State of Missouri \$ 0.370 per mile
- Personal Use of Courtesy Vehicle Within or Outside the State of Missouri \$0.240 per mile.

Foreign Travel

Travel Expense Report – Help Sheet

Before submitting travel expense reports to the COB Budget Officer, please verify that the claimant has followed the help sheet guidelines and checklist. Please check all entries for accuracy and verify that the report includes the following:

- Provide business purpose and destination of the trip and names of travelers.
- M-number is included (SSN for candidates or non-employees).
- FOP number Only fund, organization and program codes are necessary.
- Attach conference agenda, brochure, registration to confirm dates and cost.
- Original itemized meal receipts are required for anything over \$10.
- Tape all receipts to $8 \frac{1}{2} \times 11$ paper and attach to the expense report. Write employee's name and date on each page.
 - Include airfare ticket and checked baggage receipts. (Insurance is not allowed).
 - Include all meal receipts over \$10 and verify that the receipt is itemized.
 Breakfast \$12, Lunch \$15, Dinner \$30 (includes tip) not to exceed \$57/day.
 - Parking fee receipts
 - Taxi and shuttle receipts
- All receipts are to be converted to US dollars.
- For documentation, please print and submit the currency conversion rate (use Oanda) for the date the expense was incurred.
- Verify that no alcoholic beverages have been charged to the University accounts.
- Use mileage, not gas receipts when using personal vehicle. (0.37 per mile)
- Provide map indicating mileage starting from the University address (901 S. National Ave.)
- If submitting a report for new employee or candidate (someone without an M number, please provide SSN).
- Verify <u>original</u> claimant and approver signatures.

Waitlisting

Waitlisting is a new **optional** feature in the registration system that allows a student to "get in line" (i.e., get on the waitlist) for classes that are filled/closed. This automated process notifies the first student on the waitlist via Bearmail when a seat has opened up, prompting the student to register for the class. That student has exactly 24 hours after the notification is sent to register for the class. If the student does not register for the class, the next student on the waitlist is notified. How to order wireless access for a University employee or a sponsored guest of the University.

Emptying trash and recycling containers (when faculty move out)

Deep clean or paint an empty faculty office

Remove permanent markers from classroom dry erase boards

Carpets need spot cleaning or extra vacuuming.

Reset classroom clocks
